Submit your documents in person at : **Centre de formation du transport routier de Saint-Jérôme** 17 000, rue Aubin, Mirabel (Québec) J7J 1B1

Monday to Friday from 7:30 am to 21 pm (closed between 12 pm to 13 pm and from 19 pm to19:30 pm)

# <u>To register</u>

 Step 1: Register on <u>Admission FP</u> (print and sign the admission form) In the section: CSS de la Rivière-du-Nord Centre de formation professionnelle

CF du transport routier de Saint-Jérôme (CFTR)

• **Step 2**: Gather all the required documents and go in person to the address mentioned to submit your complete file for admission.

When your file has been analyzed, you will receive a call (approximately 4 to 6 weeks after receipt of your documents)

Requirements of the Quebec Ministry of Education as well as the Société de l'assurance automobile du Québec (SAAQ) For more details:https://www.cftr.cg/programmes-et-formations/truck-driver/

### Ministry of Education

You must present an academic record demonstrating the following achievements (original documents):

- Secondary school diploma (DES) or a certificate of equivalence of secondary level (TENS)
  Or
- Possess Secondary IV units in language of instruction, second language and mathematics.
  Or
- Have a general development test (GDT).
  Or
- Possess a professional studies diploma with the same category of prerequisites.
  Or
- Comparative evaluation of studies done outside Quebec.
  Or
- > Possess equivalent studies outside of Canada and be able to provide diplomas and transcripts.



### SAAQ requirements for class 1

- Possess a class 5 Quebec driver's license (different conditions apply depending on the number of months of experience).
- > Have had no license suspension or revocation in the last 2 years.
- > A less than 4 points on your driving record.
- > Have a state of health that meets the requirement of the Driver Health Regulations
  - The <u>SAAQ-Report State of Health</u> must be completed by a doctor or a specialized nurse and submitted to the SAAQ. You can drop it off online via <u>SAAQCLIC</u> OR drop it off in person <u>(Make an appointment)</u> OR mail it to an SAAQ office. Following this step, you will receive the letter "Medical decision concerning your drivers' license."

- □ Recent driving record (less than 6 months)

- Both forms signed : <u>CFTR Authorization</u> + <u>SAAQ Authorization</u>
- □ Proof of residence in Quebec if necessary (original).
